Works of art that express the beauty of nature and the interest of living things will be submitted.

November 30, 2023

[Awards]

1 Grand Prize, 2 Awards for Excellence, a few Honorable Mentions.

[Application rules]

- Applicants are limited to elementary and junior high school students as of April 2023.
- It is possible to apply even if you live abroad.
- The submitted work must be drawn by the applicant themselves.
- Please refrain from posting submissions on the web or in a contest sponsored by another company or organization.
- Only one application per person will be accepted.
- In principle, the works will not be returned. Only those who wish to have them returned to them will be able to do so. You can either take them home at the end of the exhibition period, or have them returned by delivery upon payment.

[Award Announcements]

- The winners will be contacted directly by mid-May 2024.
- All works will be displayed at the International Congress of Entomology venue in some form, not limited to the winners.

 - 5) Drawing technique (water painting, oil painting, etc.)
 - 6) How did you find out about this contest?
 - 7) Whether or not you request the return of the work

[Handling of Personal Information]

The applicants' personal information will be used only for the proper management of this contest. Please apply after confirming the "Basic Policy on the Protection of Personal Information". The consent of a parent or guardian is required for application. If you apply, it will be treated as consent from a parent or guardian.

[Basic Policy on Personal Information Protection]

The Organizing Committee of the 27th International Congress of Entomology is an organization established under the Japanese Entomological Union which will hold the 27th International Congress of Entomology in Kyoto City. Personal information to be acquired (meaning personal information prescribed in Article 2, Paragraph 1 of the "Act on the Protection of Personal Information" and Article 2, Paragraph 3 of the "Act on the Use of Numbers to Identify a Specific Individual in Administrative Procedures" and including specific personal information prescribed in Article 2, Paragraph 8 of the same Act) shall be used in accordance with this purpose, and shall respect and comply with the applicable laws and regulations on personal information and the spirit thereof, handle personal information appropriately and safely, and endeavor to protect personal information.

1. Acquisition of Personal Information

We will clarify the purpose of using personal information, etc., and handle information provided by the individual's intention.

2. Purpose of Use and Protection

Personal information acquired and used shall be used only within the scope of the purpose of use. In addition, personal information, etc. shall not be provided to a third party, except for cases in which the business is entrusted to carry out the purpose of use, cases in accordance with the provisions of laws and regulations, or cases in which it is necessary to protect the life, body or property of a person. In addition, Special Care-required Personal Information shall not be acquired or provided to a third party without the consent of the person, except for cases prescribed by laws and regulations.

3. Management System

All personal information, etc., shall be properly managed so as to prevent loss, destruction, falsification, leakage, etc., due to unauthorized access, theft, removal, and appropriate safety management measures such as necessary prevention and correction shall be taken. In addition, when business operations within the scope of the Purpose of Use are outsourced based on personal information, the contractor shall manage and supervise such business operations so as to ensure appropriate management.
